- o Budget Cindy discussed the budget deficit briefly to explain that a shortfall at the end of the fiscal year will be offset with the use of funds from the Multhaupt Fund. However, this depletes the total within the Multhaupt Fund and it will produce less revenue over time.

ANNUAL BUDGET MEETING

ST. LUKE'S CONGREGATIONAL BUDGET MEETING JUNE 25, 2023

Call to Order:

The meeting was called to order by President Cindy Maxey-Droege.

Council President's Report: Cindy Maxey-Droege

- She welcomed all, and noted this was her third year on the Church Council and second year as the Council President. She indicated the Council has had many good conversations, and that she appreciates the multi-generational membership including new members. Each person has shared stories (experiences) that help all the Council members when making decisions.
- She gave a very big thank you to Marita and Karen who spend hours each month monitoring our budget and providing monthly reports to the church council, as well as for their help in explaining these items to the Council, especially those new to Council.
- She thanked the council members that prepared the budget.
- She explained that the Church Council feels the budget respects our congregation being as responsible as we can for our talented staff, and that we have hope for our future.
- As mentioned during the recent discussions on the revenue and expenses that were held in May:
 - o The current revenue hasn't fully covered the current expenses. Therefore, funds were transferred from the Multhaupt fund to cover the deficit.
 - o The proposed expenses for next year are 6% less than the current year. The decrease is \$14,000 due to the change in Paul's insurance package (instead of private insurance, Paul will be reimbursed for utilizing the insurance provided through Diane's work).
 - o We will still likely have a deficit (for the upcoming fiscal year) that will be paid out of the Multhaupt fund.
 - o We are projecting a modest increase in the Memorial Funds.
- She also explained that the shaded areas of the budget are paid out of the Memorial Funds (MF) (interest) and the non-shaded areas are paid by Current Expense funds (CE) (offering).
- She highlighted the following budget changes:
 - Other than salaries, the largest anticipated changes are utilities, pest control, and building insurance.
 - The budget includes changing the expenses for maintenance to be covered by the memorial fund instead of the current expense funds.
 - o The proposed budget includes a 5% increase for Pastor Paul (the State conference recommended 8%, but we agreed 5% was appropriate). It also includes a 3% increase for music and Christian education staff.
 - o Pastor Paul's continuing education is proposed to come from the Memorial Fund (instead of Current Expense funds).
- **MOTION** Mike Lowry made a motion to approve the budget as presented, Jane Morman seconded. The motion was approved by a show of hands.

Adjournment: The meeting was adjourned.

Several weeks ago, I participated in a survey focused on the state of "Post-Covid" congregations across several denominations. Everyone seems to be wondering how congregations weathered the pandemic and where they find themselves now. How would the survey be perceived and what kind of results might be expected? Would it be "an autopsy" to determine congregational casualties among the many losses suffered during Covid? Or would it be "a damage assessment" to determine the injury suffered by struggles of quarantine and unexpected challenges of re-gathering? Would it perhaps provide an

opportunity to discover that congregations experienced increased vitality even in the throes of the pandemic?

The survey was supposed to take about half an hour to complete, but I spent a couple hours on it, looking up "Pre-Covid" statistics and trying to gather accurate data on where we are now. It was an opportunity to evaluate more than statistics. It was an opportunity to assess who we are and where we are as a "Post-Covid" congregation.

Some changes are obvious. Others are not so clear. We all see the offering box by the sanctuary doors, but a closer look at "giving methods" reveals an increase in electronic giving. Even some who haven't adopted electronic giving are giving monthly or even annually instead of weekly. What also needs to be noticed is that overall support of the general fund is stronger now than it was "Pre-Covid". That is partly attributable to different methods of giving but also a result of an increase in both the level of giving by members and an increase in the number of members who are now giving. (This is a direct result of the Council providing the Financial Information sessions this past year.)

Emerging from Covid as a "hybrid congregation" initially appeared to suggest lower attendance in worship. Fewer people in the sanctuary was a noticeable change. It has taken a while, but we are becoming more aware of those who worship virtually. Through the efforts taken to provide an engaged and connected worship encounter for virtual worshippers, attendance is no longer limited to those who might be in the sanctuary.

Speaking of the number of people in the sanctuary, let's look at that a little more closely. The current in-person average attendance has surpassed the "Pre-Covid" average worship attendance. The virtual participation in worship results in "bonus attendance and engagement". Or growth!

When we look even closer, we notice that a significant percentage of those who are in the sanctuary have come to St. Luke's during or since Covid. The same is true for those who worship virtually. Again, growth! Growth that brought eleven new members to the congregation this year.

One of the things that the survey evaluated was the "engagement" of those who regularly attend worship services. In other words, do those attending worship do more than come and sit in pews? The level of engagement at St. Luke's continues to be amazing! There are very few people whose connection is limited to their attendance. Council participation, committee involvement, liturgists, choirs, fellowship hosts, online hosts and a variety of other vital work is being done as more people become engaged in the life and ministry of the congregation.

This engagement has shown up in unexpected situations. One particular service, no less than half a dozen different people (at least half of whom are "Post-Covid" additions) were involved in ministering to the needs of a Sunday morning guest during a worship service. This is nothing less than a vital, compassionate congregation doing the work of making God's love known!

What might explain how St. Luke's emerged from the pandemic stronger than ever? I think it is due to the way the congregation responded during Covid. There was a decisive commitment to be the kind of congregation who offered a message of God's hope and comfort. It was what people needed and it is what we offered.

The particular "Post-Covid" needs of people might have changed. Our "Post-Covid" congregation may have changed. But as long as we remain committed to the mission of knowing and making known the hope and comfort of God, we will continue to grow stronger as a congregation.

This year we celebrated St. Luke's One Hundred and Forty-Fifth anniversary. That is a great legacy! Those who come after us will look back and wonder how the Covid Pandemic shaped the legacy of this congregation. The careful observer will undoubtedly see that the "Post-Covid", hybrid, growing, vital congregation, was strengthened by a faithful membership, committed to God and devoted to caring for the needs of others, regardless of what those needs might have been.

TREASURER'S ANNUAL REPORT 2023

TREASURER'S REPORT FISCAL YEAR 2023

The Financial Reports for the fiscal year ending June 30, 2023 can be found within this annual report. We were over budget on utilities and building insurance and had savings on Pastor Paul's health insurance for two months when we changed coverage to Dianne's group insurance. We continue to see increases in various services (as do most of us) – utilities, insurance, supplies, etc.

Our Memorial Fund Investments continue to draw the highest interest we can find and still follow the church's investment policy. For fiscal year 2023, our investments earned a little over 4.5%. Please refer to the Investment Report, located within this annual report, for investment details.

For FY-2023, Current Expense Revenue (the amount received from offerings) was less than the amount required to cover expenses. The Multhaupt Fund (the fund that has been designated to be used to cover Current Expense deficits) earned \$15,112.55; however, we had to spend \$ to cover the deficit. In FY-2024, Multhaupt earnings are anticipated to be around \$16,000. A summary of the Multhaupt Fund investments is contained within this annual report.

Since July, the start of the 2024 fiscal year, revenue received has again not met our current expense needs even though actual expenses have been within budget. Current expense offerings received through December 2023 are about \$7,300 more than last year. The budget is about \$5,150 less. Our deficit at the end of December was \$. With six months remaining in the fiscal year, there is still time for the congregation to make up a large portion of this deficit so that Multhaupt Fund principal will not have to be used.

ST. LUKE'S LIVING MEMORIAL FUNDS COMMITTEE

Sharon Franciskato, Bill Kuenne, Karen Maxey-Droege, Ginger Ruoff, and Marita Ray served on the Memorial Committee in 2022. Our memorial funds were used in many ways at St. Luke's this year.

The six funds into which our memorial monies are divided are as follows:

- 1. Scholarship Fund for Church Related Vocations for graduate studies in the field of Christian ministry.
- 2. **Local Congregation Scholarship Fund** for members of our local congregation attending college or vocational school.
- 3. **Church Program Fund** for Christian Education, library and media, youth, music and the performing arts, and van rental.
- 4. Church Improvement Fund for equipment and emergency building needs.
- 5. Church Mission Fund for community and world mission projects.
- 6. **Knapheide-Twiehaus Fund** for current expenses.

The principal amount in each of these funds is invested. As our by-laws stipulate, only earnings accrued by these funds may be spent. Thus, the memorial funds provide an ongoing source of revenue to help our church each year.

During this calendar year, \$43,387.76 was spent from memorial fund earnings. The following programs and projects were made possible by the Living Memorial Funds this year:

INVESTMENT COMMITTEE REPORT FISCAL YEAR 2023

For fiscal year 2022-23 we have realized earnings a little more than 4.0% in the Memorial and Multhaupt Funds. We

have been moving some investments into Insured CD's since rates on these have rebounded recently. The Committee conferred with our advisor at Edward Jones on several occasions by telephone and Zoom conference.

BUILDING AND GROUNDS ANNUAL REPORT CALENDAR YEAR 2023

Memorial Fund for Church Improvement (MFCI) monies were used to cover the cost of several maintenance expenditures during the year including:

- Mulch installation around the building
- Cross lighting conversion to LED lamps and dimmer system

The Fund also paid for budgeted items including, lawn care, snow removal, security system, routine HVAC system maintenance, and copier service contract.

There were no expenditures from the Major Repair portion of this fund this year. The biggest future concern for the physical plant is the AC compressors (4 units) for the sanctuary. These units are nearly 70 years old. Two of them have been taken out of service due to freon leaks that cannot be found, one is having intermittent running problems, and one is operating normally. The plan is to limp along with the current system for as long as possible. Discussions on how to upgrade/replace the units down the road have begun (nothing to report yet).

I would like to thank Paul and Anita Weida who came by regularly during the first half year to trim bushes, rake leaves, and pick up around the property. They moved to Colorado in May and will be missed. Thanks to the many who jumped in and helped with these and other maintenance activities on several occasions throughout the year. Our hybrid connections have become increasingly important to the life of our congregation. We now have members and relationships with people in Springfield, MO, Illinois, Colorado and several other states and countries. We are constantly trying to find ways to build relationships with members and friends near and far. There are people

everywhere who are looking for a church just like ours. We are trying to find ways to help them find us!

The livestreamed worship services on Facebook are important to members and visitors alike. Watching a service online is usually the first connection our congregation makes with people new to St. Luke's. Relationships with those watching are built through comments. Participating in the comments is an easy way to welcome guests and help them become comfortable and feel like they are engaged rather than on the outside looking in. Our service is also uploaded to our You Tube Channel every week.

First time in-person visitors are given a small gift (Book of Psalms and a welcome note from Pastor Paul). Be sure to welcome visitors. It's not easy coming to a church for the first time. We want everyone to feel welcomed and included when they visit. Online visitors are invited to participate in the service through comments. When you are worshiping online, be sure to participate in the comments and like and share the service. Sharing the service to your Facebook page is a great evangelism tool. That is how our service gets found by others on Facebook.

Windows Into St. Luke's is our private Facebook Group that has now grown to 155 members. Pastor Paul goes live in Windows almost every weekday. We post announcements, quotes from Pastor Paul, events, prayer requests, games and activities in Windows. Please participate in these posts by liking and commenting on them. Not only is it fun, but it builds relationships and helps us get to know each other better. Feel free to invite friends who might enjoy the posts to join Windows. Since it is a private group, only people who join the group can see the posts.

Instagram is another way we try to reach members and friends. If you are on Instagram, please follow us. Sermons, quotes, and pictures are posted weekly.

We have a very low budget for advertising but have found Facebook Ads to be effective. Our Christmas Eve Ad cost less than \$100 and reached over 2,900 people. 130 of them clicked on the Ad and went to our website to find out more about the service. We believe we had 15 or 20 visitors at our service on Christmas Eve as a result of this advertising campaign. You helped make this ad effective if you liked, commented and shared it with others.

We provide photo booths at events and during holidays. Make sure you have your picture taken when you see that a booth is set up. Then, when your pictures are posted on the Facebook page, make sure you share them and tag the church.

We can use your help! Post pictures of great times at our church. When you post them, please identify our church by "tagging" it. Use the complete name of our church (St. Luke's United Church of Christ) Don't abbreviate with UCC. People not familiar with us don't know what UCC stands for and won't be able to find our church. When you start to type the complete name of the church, it will probably pop up so you can click on it and make it a hot link to our page in your post. For help with this, just ask Marita or Nanette.
